

- » Four themes throughout:
 - Sustainability
 - Community health
 - Environmental justice
 - Economic development



What is the Climate Action Plan (CAP)?

- » Sets greenhouse gas (GHG) emissions reduction targets for the unincorporated county
- » Establishes strategies to reach those targets




- » CAP update will reflect:
 - More ambitious State GHG reduction targets
 - Updated General Plan policies and actions
 - Broad support for greater equity
 - Evolving understanding of resilience and adaptation



What is the Zoning Code?

- » Regulations that control physical development
 - Allowed uses
 - Permitting requirements
 - Specific site development standards setbacks, parking, lighting, signage, fences, trash enclosures, etc.







What is Environmental Justice?

The fair treatment of people of all races, cultures, and incomes with respect to the development, adoption, implementation, and enforcement of environmental laws, regulations, and policies.

CALIFORNIA GOVERNMENT CODE §65040.12(E)






Senate Bill 1000

- » In disadvantaged communities:
 - Reduce pollution exposure and improve air quality
 - Promote public facilities
 - Promote food access
 - Promote safe and sanitary homes
 - Promote physical activity
- » Engage the community in decision-making
- » Prioritize improvements and programs that address needs in disadvantaged communities





Draft Disadvantaged Communities





County Role – Decision-making

- » Regulate private land uses in unincorporated county
- » Implement County government projects and on-going operations
- » Support efforts and programs by other governmental, non-profit, and community organizations







SB 1000 Topic	Examples of County Role
Pollution exposure and air quality	Environmental Health Department Hazardous Materials Program
Public facilities	Health Centers Fire Stations Flood Control Libraries
Food access	Women, Infants and Children (WIC) Senior Nutrition Program Food Safety
Unsafe or unsanitary homes	Childhood Lead Poisoning Prevention Program Weatherization Program
Physical activity	Sidewalks and bikeways Parks and rec centers

Refineries

- » Refineries predate existing regulations.
- » Pollutants from refineries are regulated by other regional, State, and federal agencies.
- » County does not have authority to regulate operations.
- » County does have the authority to regulate some building or modernization projects at the refineries.
- » General Plan can address land uses around refineries, transportation infrastructure, coordination with other agencies, and emergency response planning.
- » Climate Action Plan will include information on refinery GHG emissions.
