PROJECT DESCRIPTION: The Contra Costa County 6th Cycle Housing Element Update (proposed project) is one of the required elements of the General Plan. As a policy document, the Housing Element does not normally result in physical changes to the environment but rather encourages the provision of affordable housing within the land use designations shown in the Land Use Element of the General Plan. The Housing Element identifies policy direction to meet the housing needs of the County by preserving existing homes and clarifying priorities for housing creation. The proposed Housing Element will include an overview of housing policies and programs and will identify locations that can accommodate future housing.

The proposed project will require that the County redesignate land to meet the Regional Housing Needs Allocation (RHNA) of 7,610 total housing units. The County also intends to comply with No-Net-Loss (Gov. Code Section 65863) through identifying a surplus of sites available to meet its RHNA allocation. In total, the County's surplus unit capacity is 2,485 units. In order to meet this requirement, the County must redesignate up to approximately 560 acres of land.

The proposed project would require changes in land use designations for sites that currently allow residential uses but would need to be redesignated to allow for increased residential density, in addition to sites with designations that do not currently allow residential density and would need to be redesignated to allow residential development.

The Housing Element Update also includes an additional 92 acres of land that do not require a designation or zone change but are counted toward the County's RHNA.

REVIEW AND COMMENT PERIOD: There will be a forty-five (45) day review and comment period for this Draft Environmental Impact Report, beginning on February 3, 2023, and closing on March 20, 2023. Comments on this Draft Environmental Impact Report should be submitted before 5:00 p.m. on Monday, March 20, 2023, to:

In addition, the Contra Costa County Planning Commission is anticipated to conduct a public hearing to receive comments on the adequacy of the Draft Environmental Impact Report on Wednesday, May 24, 2023 at 6:30 p.m. The Contra Costa County Planning Commission meeting is conducted at 30 Muir Road, Martinez, CA 94553
